

Rules for the T Phone competition as part of the Jizerská 50

(hereinafter referred to as the "**Rules**")

T-Mobile Czech Republic a.s., with registered office at Tomíčková 2144/1, 148 00 Prague 4, ID 649 49 681, entered in the Commercial Register maintained by the Municipal Court in Prague, Section B, Insert 3787

I. General provisions

1. T-Mobile Czech Republic a.s. (hereinafter referred to as the "**Organizer**") announces a competition called "T Phone competition as part of the Jizerská 50" (hereinafter also referred to as the "**Competition**"), which will take place as part of the Jizerská 50 race held on 8. 2. 2024 – 11. 2. 2024 in Bedřichov and its surroundings (hereinafter referred to as the "**Race**").
2. The rules governing the conditions of the Competition are available in full on the competition page <https://jiz50.cz/t-mobile> (hereinafter referred to as the "**Competition Page**").
3. The Competition takes place in the Czech Republic at the location and on the days of the Race (hereinafter referred to as "**Competition Period**"). The Organizer reserves the right to change the Competition Period and to cancel the Competition at any time.

II. Conditions for participation in the Competition

1. The Competition is open to any individual who meets the eligibility requirements for the Competition as defined below (hereinafter referred to as the "**Competitor**"). The Competitor acknowledges that if he/she is under 18 years of age, he/she must secure the consent of his/her legal guardian to participate in the Competition. If such a Competitor is unable to prove the consent of his/her legal guardian, he/she will forfeit his/her right to a prize in the Competition in the event of winning.
2. Any person who fails to comply with any of the participation conditions set out in these Rules is not eligible to enter the Competition, and if they do enter the Competition, they are not entitled to a Prize and may be excluded from the Competition at any time without compensation.
(collectively referred to hereinafter as the "**Conditions**")

III. Basic information about the Competition

1. In order to participate in the Competition, you must come to the venue of the Race, namely to the Organizer's presentation stand at the venue of the Race in the Bedřichov cross-country skiing area (hereinafter referred to as the "**Competition Venue**"), and hand in your old mobile phone (hereinafter referred to as the "**mobile phone for recycling**") to a special box for recycling.
2. Everyone who fulfils the condition under the previous paragraph will receive a scratch card for each mobile phone submitted for recycling, after which the Competitor can win one of 12 T Phone mobile phones or some other prize (sports equipment, promotional items, etc.) (collectively referred to hereinafter as the "**Prize**").
3. In order to claim the Prize, it is necessary for the Competitor to scratch the scratch ticket immediately at the Competition Venue, as this is also where the award of any Prize will take place.
4. If a Winner fails to comply with any of the conditions of the Competition set out in these Rules, the prize will not be awarded to him/her. Prizes cannot be paid in cash and are not legally enforceable. Any Prize not awarded or provided to a Winner will be forfeited to the Organizer. If the Winner fails to cooperate and claim the Prize at the Competition Venue, the Prize will be forfeited to the Organizer.

IV. Concluding provisions

1. The Organizer reserves the right to shorten, suspend or cancel the Competition or amend the Rules at any time without giving any reason. Any changes to the Rules will take effect upon their announcement on the Competition Page. A change to the Competition Rules does not entitle the Competitor to reimbursement of any costs incurred in the Competition. The Organizer may, at its sole discretion, declare the Competition void for any technical or other system error. If, for any serious reason which is likely to interfere with or otherwise adversely affect the administration,

security, fairness, integrity or proper conduct of the Competition, the Competition cannot proceed as planned, the Organizer reserves the right, at its sole discretion, to cancel, terminate, modify or suspend this Competition.

2. The Organizer shall not be liable for any incorrect or inaccurate information in connection with the Competition (whether caused by human error or technical fault), nor for the completeness of extracts from these Rules which may be published in abridged versions in promotional materials, nor for typographical errors.
3. The Competition Organizer reserves the right to review all the Competition Conditions and, in the event of a dispute, to assess and finally decide any claim for the award or non-award of a Prize, including the right to exclude any Competitor from the Competition in the event that such Competitor is in breach of these Rules or generally applicable law or is reasonably suspected of such activity.
4. The Organizer advises that any deliberate attempt to damage any website, competition application or to interfere with the legitimate operation of the Competition may qualify as a breach of applicable law and these Rules and may also entitle the Organizer to compensation for damages.
5. The rules are valid and effective from 8. 2. 2024.
